Background

This position will be involved in the tobacco control work of the International Union Against Tuberculosis and Lung Disease (The Union). This program is funded by Bloomberg Philanthropies and is designed to implement best practices of tobacco control policies at the global level. The position will be based in the Vital Strategies offices in New York City. Applicants must have a valid work permit to work in New York City.

Specific Duties:

- Provide significant input into the planning of strategic development of the Tobacco Control Department;
- Identify new directions or areas of work for the Tobacco Control Department and assist the Director of Tobacco Control in exploring opportunities of collaboration and funding;
- Support and oversee country and regional teams in program implementation and partner coordination.
- Provide strategic input to Director of Tobacco Control on countries of program operations.
- Liaise between regional and country teams and the Director of the Tobacco Control Department to facilitate communication and timely sharing of information;
- Lead the monitoring of the tobacco industry and interpret the industry fallacies from scientific point of view.
- Lead the monitoring of the debate around e-cigarettes and new products.
- Publish opinion pieces on key tobacco control issues e.g. industry and new products.
- Lead the monitoring of the scientific literature on all tobacco control issues and provide summary updates for the Department.

- Support the Director of Tobacco Control in day-to-day functioning of the Tobacco Control Department;
- Attend conference calls and meetings with Bloomberg partners on behalf of the Director of Tobacco Control Department when needed;
- Assist the Director of Tobacco Control Department in monthly, quarterly, and annual reporting to Bloomberg Philanthropies.
- The incumbent will report to the Director of Tobacco Control Department at The Union;
- This position will be based in New York City;
- Other duties as required by the Director of the Tobacco Control Department;
- Competitive compensation commensurate with education and experience will be provided.

Qualifications and skill set:

- Doctoral Degree of Public Health required;
- Minimum 10 years' work experience in the field of public health, Minimum 5 years' work experience in the field of tobacco control or NCD, prior experience of working in international settings strongly preferred;
- Excellent communication skills, both face-to-face and in writing;
- Fluency in written and spoken English, fluency in another foreign language a plus;
- Organized, responsive, attentive to details, and collaborative;
- Up to 25% of travel is required.
