

# Global Safety and Occupational Health Officer Vital Strategies

## **The Position**

Vital Strategies is seeking qualified candidates for the position of Global Safety and Occupational Health Officer. The Global Safety and Occupational Health Officer will be responsible for approximately 350 Vital Strategies employees and consultants at their main work place and when they travel. Vital Strategies currently has offices in Brazil, France, New York, Singapore and Tanzania. An additional office is in the process of being registered in India. This is a full-time position, preferably based in New York City. If based in NYC, applicants must have a valid work permit to work in the United States.

#### **Overall Role:**

Reporting to the Chief Operating Officer, the Global Safety and Occupational Health Officer will be responsible for the development, implementation and communication of safety and security, and occupational health, procedures.

## **Specific Duties**

- Provide expert consultation to support staff who manage programs and/or travel in high risk areas.
- Develop and maintain an effective systematic security incident report mechanism; support and facilitate routine security debriefings.
- Conduct risk assessments and ensure action is taken mitigate security and health risks in Vital Strategies offices, in places where staff are based, and in locations where staff travel.
- Develop and maintain global and country office occupational health plans, policies, procedures, and related service contracts to address:
  - Health risks from field-based work
  - Travel medicine needs
  - Staff exposure to community health risks (outbreaks, etc.)
- Develop and present analysis of federal, state, and local laws, directives, guidelines, and codes related to environmental and occupational health control matters; prepare routine reports and updates; ensure local compliance
- Develop standard operating procedures, guidelines, and policies for Vital Strategies on safety, security and occupational health.

- Develop and implement training and education materials for supervisors, staff, and consultants, and where appropriate, organize external trainings around security, health and occupational health.
- Support development of global and country-specific emergency planning procedures.
   Support planning and policy development around field presence as required.

#### Qualifications and skill set:

- Bachelor's degree required
- 5-10 years' related work experience, preferably in an international organization, in security management and security training.
- Advanced degree in Public Health, Occupational Health, Security or related field can replace 3 years of professional experience
- Experience evaluating and mitigating safety, health and security risks to staff
- Principles and techniques of occupational health risk prevention, preferred
- Experience in safety and security management for staff working in difficult environments (Vital Strategies does not work in conflict zones)
- Effective delivery of staff and managerial training
- Excellent written, oral, and interpersonal communication skills in English
- Ability to prioritize effectively and execute tasks in a high-demand environment, and demonstrate excellent judgement
- Ability to respond immediately, to provide leadership and support security or health related emergencies as they arise
- Desire to work in a team-oriented, collaborative environment
- · Desire and willingness to travel internationally
