Background

This position will be involved in the tobacco control work of the International Union Against Tuberculosis and Lung Disease (The Union). This program is funded by Bloomberg Philanthropies and is designed to implement best practices of tobacco control policies at the global level. The position will be based in the Vital Strategies offices in New York City. Applicants must have a valid work permit to work in New York City.

Specific Duties:

- Lead the planning and implementation of countering industry work at The Union's Tobacco Control Department;
- Provide strategic input to the Director of Tobacco Control Department on the implementation of the STOP initiative;
- Coordinate country and regional teams on the implementation of the STOP initiative;
- Provide strategic input to country and regional teams on countering industry activities as part of the Bloomberg grants program;
- Liaise with Technical Advisors of the Union in providing support to country and regional teams as well as to STOP partners;
- Contribute to the development of technical reports on industry monitoring as part of the STOP initiative;
- Publish opinion pieces on issues related to industry interference;

- Lead the day-to-day coordination with STOP partners;
- Facilitate the communication and timely sharing of information between the Director of Tobacco Control Department, country and regional teams, and the STOP partners;
- Liaise with the Communications Department of The Union on promoting the activities of the STOP initiative;
- Liaise with Bloomberg partners on collaboration under the STOP initiative as needed;
- Represent the Union and the Director of Tobacco Control Department at conference calls and meetings with STOP partners and Bloomberg;
- Assist the Director of Tobacco Control Department in monthly, quarterly, and annual reporting to Bloomberg Philanthropies on the STOP initiative;
- The incumbent will report to the Director of Tobacco Control Department at The Union;
- This position will be based in New York City;
- Other duties as required by the Director of the Tobacco Control Department;
- Competitive compensation commensurate with education and experience will be provided.

Qualifications and skill set:

- Master's Degree of Public Health required;
- Minimum 10 years' work experience in the field of public health, Minimum 5 years' work experience in the field of tobacco control or NCD, prior experience of working in international settings strongly preferred;
- Excellent communication skills, both face-to-face and in writing;
- Fluency in written and spoken English, fluency in another foreign language a plus;
- Organized, responsive, attentive to details, and collaborative;
- Up to 25% of travel is required.
