Vital Strategies will serve as the lead implementing partner for Breathe Jakarta.

The Position

The Consultant-Breathe Jakarta will play a key role in overseeing the implementation of the Breathe Jakarta Program, ensuring alignment of activities with the city's priorities and objectives as outlined in the program's strategy. This position will involve engaging with and convening city officials, air quality management stakeholders, and civil society partners to ensure effective delivery of program activities and the achievement of desired outcomes. S/he will also be responsible for maintaining key stakeholder relationships at national and regional levels, facilitating and coordinating technical assistance, contributing to project management direction, maintaining regular communications, monitoring, and reporting on progress. This role is ideal for experienced managers who aspire to develop new skills and gain experience coordinating complex projects within a transdisciplinary team of colleagues. The Consultant-Breathe Jakarta will also support the development of knowledge products, and provide strategic guidance based on the program's goals and objectives.

- Assist with other Vital Strategies duties and ad hoc requests as specified by supervisor
